**Tenant agrees that all charges for space rental, repairs, or any other services or materials accruing under the terms of this contract shall give the landlord a lien upon tenant's boat and/or motor and that no boat shall be removed from the landlord's premises until all charges are paid.**

**Deposits on seasonal slips are non-refundable. Submission of payment in full, a completed contract and evidence of insurance in the amount of \$150,000 is required by March 31, 2015. Failure to complete these requirements by due date will result in forfeiture of slip, as well as, deposit.**

*It is agreed that this contract is performable and venue shall be in the state and county of Landlord.*
