BE IT ORDAINED by the Mayor and Common Council of the City of Gloucester City, in the County of Camden, and State of New Jersey that Article XVI, <u>SECTION 1604.</u> of the Zoning Ordinance of the City of Gloucester City be amended and <u>SECTION 1604.</u> 14. be added as follows:

SECTION 1604. PERMITTED SIGNS.

- 14. Banner signs at business or commercial establishments provided that: There shall be no more than two (2) banner signs per establishment; such signs shall be erected for no longer than thirty (30) days per sign; the text of these signs shall not be repeated during any calendar year (January 1st to December 31st) at each establishment; the total area of banner signs per establishment shall not exceed thirty (30) square feet; and banner signs shall be affixed to the building facades only.
