RESOLUTION AUTHORIZING AND DIRECTING THE GLOUCESTER CITY PLANNING BOARD TO UNDERTAKE A PRELIMINARY INVESTIGATION TO DETERMINE WHETHER THE PROPOSED STUDY AREA WHICH INCLUDES BLOCK 270, LOT 12, NEW JERSEY DEPARTMENT OF TRANSPORTATION PARCEL MAPS FIGURES 2, 3 AND 4 AS WELL AS THE ADJACENT WOODED VACANT NEW JERSEY DEPARTMENT OF TRANSPORTATION (PARCEL VX8A2) AS REFLECTED IN THE ATTACHED EXHIBITS ATTACHED HERETO AND MADE A PART HEREOF ARE TO BE DELINEATED AS AN AREA IN NEED OF REDEVELOPMENT PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW (N.J.S.A. 40A:12A-1 ET SEQ)

WHEREAS, the Gloucester City Planning Board adopted the official Gloucester City Master Plan pursuant to N.J.S.A. 40:55D-28(a) on January 24, 1996 and subsequently adopted a re-examination to said Master Plan on June 18, 2003; and

WHEREAS, the official Gloucester City Master Plan and re-examination report provide that various locations throughout the City of Gloucester City should be considered for designation as redevelopment areas pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. ("LHRL");

WHEREAS, the LRHL provides a mechanism to assist local governments in efforts to promote programs of redevelopment; and

WHEREAS, the LRHL sets forth the procedures for the City to declare an area in need of redevelopment, along with the development and effectuation of a redevelopment plan; and

WHEREAS, pursuant to the required redevelopment procedures, specifically set forth in N.J.S.A. 40A:12A-6, no area of a municipality shall be determined a redevelopment area unless the governing body of the municipality shall, by Resolution, authorize the Planning Board to undertake a preliminary investigation to determine whether a proposed area is a redevelopment area meeting the criteria set forth in N.J.S.A. 40A:12A-5; and

WHEREAS, the New Jersey Legislature adopted, and the Governor signed, P.L. 2013, Chapter 159, which amended the LRHL, including the procedural requirements of N.J.S.A. 40A:12A-5 and N.J.S.A. 40A:12A-6; and

WHEREAS, pursuant to P.L. 2013, Chapter 159, "[t]he resolution authorizing the planning board to undertake a preliminary investigation shall state whether the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area other than the use of eminent domain ("Non-Condemnation Redevelopment Area") or whether the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use is a redevelopment area, including the power of eminent domain ("Condemnation Redevelopment Area"); and

WHEREAS, the Mayor and Common Counsel of the City of Gloucester City seek to authorize and recommend the City Planning Board to conduct a preliminary investigation of the Study Area as an area in need of redevelopment to be a Condemnation Redevelopment Area; and

WHEREAS, the Area in question is located at or near Main Street including the Plaza 1000 Building and the adjacent areas located at Block 270, Lot 12, New Jersey Department of Transportation Parcel Maps Figures 2, 3 and 4, as well as the adjacent wooded vacant New Jersey Department of Transportation Parcel VX8A2 as reflected in the attached exhibits hereto, may benefit from the tools available to municipalities under the LRHL and efforts to encourage private development with existing owners for increased employment and housing opportunities, tax ratables and other benefits which communities generally derive from the redevelopment of lands in these areas; and

WHEREAS, the City finds it to be in the best interest of the City and its residents to authorize the City Planning Board to undertake such preliminary investigation of the Study Area as a Condemnation Redevelopment Area; and

WHEREAS, the Gloucester City wishes to direct the City of Planning Board to undertake a preliminary investigation utilizing Environmental Resolutions, Inc., to prepare the preliminary investigation, to determine whether the proposed Study Area, which includes Block 270, Lot 12, New

Jersey Department of Transportation Parcel Maps Figures 2, 3 and 4, as well as the adjacent wooded vacant New Jersey Department of Transportation Parcel VX8A2 as reflected in the attached exhibits hereto, qualifies as an area in need of Condemnation Redevelopment pursuant to N.J.S.A. 40A:12A-5; and

WHEREAS, Lazgor, L.L.C. and Gloucester City have entered into an Escrow Agreement whereby Lazgor, L.L.C. shall be responsible to pay for all expenses incurred by the City and Planning Board in conjunction with the request; and

WHEREAS, the Mayor and Common Council are empowered to authorize this preliminary investigation to be conducted by the City Planning Board pursuant to N.J.S.A. 40A:12A-6 as a Condemnation Redevelopment Area.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Common Council of the City of Gloucester, County of Camden, State of New Jersey as follows:

- 1. The provisions of the WHEREAS clauses set forth above are incorporated herein by reference and made a part hereof.
- 2. The Gloucester City Planning Board is hereby authorized to undertake a preliminary investigation, utilizing Environmental Resolutions, Inc. to prepare the preliminary investigation, pursuant to a notice to conduct a hearing and comply with other requirements of the LRHL, in order to recommend to the City whether the area comprising the Study Area is an area in need of Condemnation Redevelopment according to the criteria set forth in N.J.S.A. 40A:12A-5.
- 3. Pursuant to New Jersey P.L.2013, Chapter 159, the redevelopment area determination shall authorize the City to use all those powers provided by the Legislature for use in a Condemnation Redevelopment Area, other than the use of eminent domain.
- 4. The Gloucester City Planning Board shall provide a written Report to the Mayor and Common Council setting forth its findings resulting from such preliminary investigation and shall recommend to the Mayor and Common Council whether said properties are an "Area in Need of Redevelopment" under the meaning and intendment of the LRHL.
- 5. The Gloucester City Planning Board shall submit its findings and recommendations to the Mayor and Common Council in the form of a Resolution with supporting documents.

Section B. <u>Municipal Employees</u>

The individuals appointed to these positions are appointed as provided in the statutes of the State of New Jersey to terms and specified for the position and are not covered under the provision of the New Jersey Civil Service Commission as regular appointments. They are entitled to benefits as contained in the ordinance of the City covering non-represented employees and full time employees. Those who are full time employees are entitled to health benefits as provided to the non-represented city employees. These salaries shall be effective on January 1, 2016. No employee may be paid above the maximum and the Governing Body, by Resolution, shall set the amount of annual salary at a rate within the range.

SECTION 2. The salaries specified in Section One (1) of the Ordinance shall be paid in lieu of any salary, bonus, or additional pay for any or all holidays heretofore granted.

SECTION 3. All Ordinances or Resolutions or parts thereof, inconsistent with the provisions of this ordinance shall be and the same are hereby repealed, but only to the extent of such inconsistency.

SECTION 4. All salaries specified in this ordinance shall take effect as of final adoption and shall continue in effect until and amendment to this ordinance or passage of any ordinance inconsistent with this ordinance.

ORDINANCE OF THE CITY OF GLOUCESTER County of Camden, State of New Jersey # // -2017

An Ordinance Establishing Which Appointed Officials Within the City of Gloucester City Are Eligible For Participation In the Defined Contribution Retirement Program

WHEREAS, the State Legislature recently adopted Chapter 92 of the Laws of 2007 (N.J.S. 43:15C-1 et seq.) to create the Defined Contribution Retirement Program to provide retirement benefits to various county and municipal officials; and,

WHEREAS, N.J.S. 43:15C-2 requires the governing body of each county, municipality, and other local entity to adopt, as appropriate, either a resolution or ordinance to determine the positions that are substantially similar in nature to the advice and consent of the Senate for appointments by the Governor of the State, pursuant to guidelines or policy that shall be established by the Local Finance Board in the Department of Community Affairs, and for which officials appointed to such positions shall be eligible for and shall participate in the Defined Contribution Retirement Program, subject to the provisions of law; and,

WHEREAS, the Mayor and Common Council of Gloucester City have considered the guidelines issues by the Local Finance Board.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Common Council of Gloucester City as follows:

- 1. Pursuant to N.J.S. 43:15C-2, the following positions are deemed to be eligible for and shall participate in the Defined Contribution Retirement Program:
 - a. City Administrator;
 - b. City Solicitor who does not meet the status as an independent contractor;
 - c. Municipal Court Judge;
 - d. Municipal Prosecutor;
 - e. Municipal Public Defender;

- 2. Individuals serving in the following positions are exempt from Defined Contribution Retirement Program membership, pursuant to N.J.S. 43:15C-2:
 - a. Registered City Clerk;
 - b. Chief Financial Officer;
 - c. Treasurer;
 - d. Public Works Director;
 - e. Tax/Utility Collector;
 - f. Tax Assessor;
 - g. Court Administrator;
 - h. Qualified Purchasing Agent;
 - i. Code Enforcement Officer;
 - j. Zoning Code Official;
 - k. Construction Code Official;
 - 1. Licensed Uniform Sub Code Officials and Inspectors;
 - m. Registrar of Vital Statistics;
 - n. Licensed Uniform;
 - o. All other qualifying employees as provided for by law.
- 3. This Ordinance shall be implemented, construed and subject to the aforesaid Chapter 92 of the Laws of 2007 (N.J.S. 43:15C-1 et seq.) as amended from time to time, and any regulations or guidance documents from the Local Finance Board or the Division of Pensions and Benefits.
- 4. Should any part or parts of this Ordinance be held to be invalid by any competent court of law, such invalidity shall only affect the part or parts held to be invalid, and all other parts shall remain in effect.

 - (1) Change \$25 to \$50
 - (3) Change \$25 to \$50

BE IT FURTHER ORDAINED that all prior ordinances inconsistent with this ordinance are repealed only to the extent of such inconsistency.

BE IT FURTHER ORDAINED that if any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

BE IT FURTHER ORDAINED this Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.

ORDINANCE AMENDING A PORTION OF CHAPTER 5B OF THE CODE OF THE CITY OF GLOUCESTER CITY

WHEREAS, for clarity and consistency Section 1(c) of Chapter 5B of the Code of the City of Gloucester City requires an Amendment; and

WHEREAS, it is in the best interest of the City of Gloucester City to Amend this provision; and

WHEREAS, after due consideration and deliberation, the Mayor and Common Council of the City of Gloucester City desire to amend section 1 (c) of Chapter 5B of the Code of the City of Gloucester City

THEREFORE BEING ORDAINED by the Mayor and the Council of the City of Gloucester City, County of Camden, State of New Jersey as follows:

Section 1(c) of Chapter 5B of the Code of the City of Gloucester City shall be amended to read as follows:

Subject to the limitations of this Ordinance, any entity meeting the definition of "professional business entity" under this section may contribute a maximum of \$1,200.00 per election cycle for any candidate(s) or Gloucester City Party Committee, without violating section 1 (a) of this ordinance. However, any entity meeting the definition of "professional business entity" under this section, including such principals, partners and officers of the entity in the aggregate, may not annually contribute for any purpose, in excess of a total of \$2,400.00 to all Gloucester City candidates and officeholders with ultimate responsibility for the award of a contract.

AN ORDINANCE TO RELEASE, VACATE AND EXTINGUISH ANY AND ALL PUBLIC RIGHTS IN AND TO A PORTION OF BIRCH AVENUE SUBJECT TO CERTAIN TERMS AND CONDITIONS

WHEREAS, the Mayor and City Council of the City of Gloucester City, is of the opinion that the public interest will best be served by abandoning, vacating, releasing and extinguishing any and all public rights which the City of Gloucester City may have in and to the following described portion of Birch Avenue.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey, as follows:

- 1. The public rights and interests in a portion of Birch Avenue, between the southerly line of Market Street and the northerly line of Oriental Avenue, more particularly described in accordance with Exhibit "A" attached hereto, are hereby vacated, abandoned and released.
- 2. The vacation set forth herein expressly reserves and excepts from said vacation, all rights and privileges possessed by any and all public utilities, as defined by R.S. 48:2-13, and by any cable television company, as defined in the Cable Television Act, P.L. 1972, c. 186, (C. 48:5A-1 et seq.), to maintain, repair and replace their existing facilities in adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, to be vacated.
- 3. This Ordinance shall take effect immediately after final passage and publication as required by law.
