**RESOLUTION AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT
BY AND BETWEEN THE CITY OF GLOUCESTER CITY AND THE GLOUCESTER CITY
BOARD OF EDUCATION FOR SCHOOL RESOURCE OFFICERS**

WHEREAS, the School District seeks the services of School Security Officers; and

WHEREAS two (2) School Resource Officers to be assigned to the School District to be stationed each at Gloucester City High School and Middle School; and,

WHEREAS, the School District seeks the services of one (1) Class III Police Officer to be assigned to the Cold Springs School; and,

WHEREAS, the School District seeks the services of one (1) Class II Police Officer to be assigned to the Gloucester City Middle School to patrol during nights and weekends at a timeframe agreed upon between the City and School District; and

WHEREAS, recent events throughout the nation have suggested that the presence of school resource officers within schools can serve as a stabilizing force for school children and can further the development of student confidence in law enforcement; and,

WHEREAS, both the City and School District recognize the potential benefits of this School Resource Officer Program (the "Program") to the citizens of Gloucester City and to the students and staff of the School District; and,

WHEREAS, it is in the best interests of the parties to continue the Program effective July 1, 2023 through June 30, 2025; and,

NOW, THEREFORE BE IT RESOLVED, that Mayor and Common Council of the City of Gloucester City, County of Camden and State of New Jersey as follows:


1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.

2. The City of Gloucester City hereby authorizes a Shared Services Agreement, pursuant to the New Jersey Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et. Seq., by and between the City and the Gloucester City School District.
3. The Mayor, Chief of Police and/or City Clerk are hereby authorized to execute the Shared Services Agreement in the form attached heretofore, Exhibit "A" and to take any and all actions necessary to carry out the intended purposes of the Shared Services Agreement.
4. This Resolution will become effective upon the adoption of a similar resolution by the Gloucester City School District authorizing the execution of the Shared Services Agreement attached hereto as Exhibit "A".
5. The Shares Services Agreement shall be attached to this Resolution upon execution and kept on file in the Office of the City Clerk of the City of Gloucester City.
6. The subject Shared Services Agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
