ORDINANCE AUTHORIZING THE SUBDIVISION OF PROPERTY

Whereas, Gloucester City owns property located on Highland Avenue, know as Block 245, lot 3.01; and

Whereas, Ember and Charles Ogle wish to purchase a portion of the property owned by the City of Gloucester City; and

Whereas, a portion of the property has a driveway located on it which driveway services the adjacent property owned by the Ogles; and

Whereas, the property has been surveyed by Donovan Surveyors on December 21, 2015; and

Whereas, the survey delineates the portion of the property with the driveway to be a 16' by 140'; and

Whereas, the Ogles have offered to purchase the subdivided portion for \$2,500.00; and

Whereas, it is in the best interests of the City of Gloucester City to accept payment for the subdivided parcel; and

Whereas, The City of Gloucester City has previously adopted a resolution authorizing entering into an agreement of sale with the Ogles; and

Whereas, The City of Gloucester City and the Ogles have previously entered into an agreement of sale regarding the property;

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey:

- 1. The 16' by 140' portion of the property described on the Donovan survey shall be deemed subdivided by this ordinance;
- 2. The remaining parcel shall remain the property of the City of Gloucester City and shall continue to be known as Block 245, Lot 3.01, as described by the aforementioned survey;
- 3. The subdivided parcel shall be consolidated by deed into Block 245, lot 3.02 (known as 316 Highland Avenue), simultaneously with the recording of the subdivision deed, and this subdivided parcel shall not be a stand alone, developable parcel;
- 4. This transaction is conditioned upon all the terms and conditions of the agreement of sale being complied with by the Ogles;
- 5. All deeds and other documents necessary to complete the subdivision shall be prepared by the Gloucester City Solicitor;
- 6. The mayor and clerk are authorized to execute the subdivision deeds:

- 7. All title expenses, closing costs, recording fees, legal fees incurred by the City and other expenses related to this transaction shall be borne by the Ogles;
- 8. Settlement shall take place when the minor subdivision is not appealable.
