**ORDINANCE AMENDING PORTIONS OF CHAPTER 4 OF ARTICLE VII
(ADMINISTRATIVE CODE) OF THE CODE OF THE CITY OF GLOUCESTER CITY**

Whereas, The Mayor and Council of the City of Gloucester City has determined it would be in the best interest of the City to create a Department of Utilities which was formerly a Division in the Department of Public Works; and

Whereas, it is more descriptive to refer to that Department as the Department of Utilities; and

Whereas, after due consideration and deliberation, that Mayor and Council of the City of Gloucester City desire to make certain amendments to Article VIII of the Administrative Code of the City of Gloucester City; and

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, and State of New Jersey as follows:

1. Article VIII shall now be known as the Departments Public Works and Department of Utilities;
2. Section 4-38 A. shall be amended to read Department of Public Works of the City of Gloucester City is hereby established for the purpose of providing and administering all Municipal Services of the City, including maintenance of Municipal buildings, facilities, parks, play grounds, real estate and generally performing all of the tasks and services previously performed by the Department of Streets, playgrounds.


Section 4 – 38 B. The Department of Utilities shall now be established to administer all services providing water and sewer services in the City of Gloucester City.

Both such Departments shall be under the stranding Committee of Public Works as appointed by the Mayor and until such time Common Council shall make further amendments.

3. Section 4-41 shall be amended to read Director of the Department of Utilities.
4. Section 4.41(A) – The Mayor and Common Council of the City of Gloucester City hereby create the position of Director of the Department of Utilities, as the Chief Administrator of that Department and shall be an unclassified appointment and a Municipal Department Head.

Current Section 4-42 C. (1), (3), (4) and (5) shall be incorporated in Section 4- 39 as to the responsibilities of the Superintendent of Public Works.


Current Section 4-42 C . (2), (3) (4) and (5) shall be incorporated and be responsibilities of the Director of Utilities.




