ORDINANCE OF THE CITY OF GLOUCESTER, COUNTY OF CAMDEN, AND STATE OF NEW JERSEY, SUPPLEMENTING AND MODIFYING CHAPTER 87, VEHICLE AND TRAFFIC, OF THE CODE OF THE CITY OF GLOUCESTER

WHEREAS, the Mayor and Common Council of the City of Gloucester having considered supplementing and modifying Chapter 87, Vehicle and Traffic of the Code of the City of Gloucester, specifically §87-10, Schedule C: no parking to include a section of the north side of Center Street; and

WHEREAS, the Mayor and Common Council of the City of Gloucester have determined that it is in the best interest of the resident's health, safety and welfare to restrict parking at the aforesaid location.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Common Council of the City of Gloucester, County of Camden, and State of New Jersey, that Chapter 87, specifically §87-10, Schedule C: no parking be amended to add the following:

SECTION 1:

Center Street North Broadway 105 feet

SECTION 2: If any subsection, paragraph subsection, clause or provision of this ordinance shall be judged by the Courts to be invalid, such adjudication shall apply only to that section, paragraph, subsection, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

SECTION 3: This ordinance shall take effect upon final adoption, publication and filing of a copy of said ordinance with the Camden County Planning Board, all in accordance with the law.

SECTION 4: This Ordinance shall become effective immediately upon final passage and publication as required by law.
