**ORDINANCE AUTHORIZING ROADWAY CHANGES**

Whereas, The Gloucester City Middle School opening will create traffic concerns; and

Whereas, The City wished to regulate traffic near and around the Middle School; and

Whereas, The health and safety of the students, employees of the school and the residents of the City of Gloucester City needs to be protected; and

Whereas, Placing certain directional and parking restrictions on the streets near the Middle School will promote the health and safety of the residents of the City of Gloucester City; and

Whereas, The City desires to make the changes to limit the directional of travel on certain streets;

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey:

That the following traffic patterns shall be instituted:


1. Powell Street- from Broadway to Sixth Street, one way west bound
2. Powell Street- from Fourth Street to Fifth Street, one way west bound
3. Hunter Street- from Sixth Street to Broadway, one way east bound
4. Hunter St.- from Fifth Street to Fourth Street, one way east bound
5. Division Street- from Broadway to Sixth Street, one way west bound
6. Cherry Street- from Sixth Street to Broadway, one way east bound
7. Sixth Street at Market Street- right turn only, Monday to Friday 7:00 AM to 4:00 PM
8. Market Street- Permit parking only permitted in front of 511 Market Street to and including 533 Market Street. No parking on Market Street from Atlantic Street to 511 Market Street
9. Sixth Street- Market to Jersey Street., parking on the East side only, no stopping or standing
10. Fifth Street- Market Street to Jersey Street, parking on the West side only, no stopping or standing
11. Fifth Street - Market Street to Powell Street, no parking on either side of the street

12. Jersey Street- from Fifth Street to Sixth Street, no stopping or standing Monday to Friday  
7:00 AM to 4:00 PM

13. Fifth Street-one way from Market Street to Jersey Street

14 Sixth Street-one way from Jersey Street to Market Street


This ordinance shall become effective July 1, 2017.




