ORDINANCE OF THE CITY OF GLOUCESTER CITY, COUNTY OF CAMDEN, AND STATE OF NEW JERSEY, SUPPLEMENTING AND MODIFYING CHAPTER 87, VEHICLE AND TRAFFIC, OF THE CODE OF THE CITY OF GLOUCESTER CITY

WHEREAS, the Mayor and Common Council of the City of Gloucester City having considered supplementing and modifying Chapter 87, Vehicle and Traffic of the Code of the City of Gloucester City, specifically §87-10, Schedule C: no parking on Broadway extending 25 feet on both the North and South side of the driveway in front of Gorman Manor, property being Block 131, Lot 21; and

WHEREAS, the Mayor and Common Council of the City of Gloucester City have determined that it is in the best interest of the resident's health, safety and welfare to restrict parking at the aforesaid location; and

WHEREAS, the Mayor and Common Council of the City of Gloucester have determined that the elimination of obstructions in both the view of pedestrians and vehicular traffic is beneficial to the resident's of the City of Gloucester City.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Common Council of the City of Gloucester City, County of Camden, and State of New Jersey, that Chapter 87, specifically §87-10, Schedule C: no parking be amended to add the following:

SECTION 1:

There should be no parking on the section of Broadway that extends 25 feet in each direction both North and South from the driveway in front of the property located at 430 South Broadway, Gorman Manor, and also knows as Block 131, Lot 21 and along the east side of Broadway.

SECTION 2: If any subsection, paragraph subsection, clause or provision of this ordinance shall be judged by the Courts to be invalid, such adjudication shall apply only to that section, paragraph, subsection, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

SECTION 3: This ordinance shall take effect upon final adoption, publication and filing of a copy of said ordinance with the Camden County Planning Board, all in accordance with the law.
