## ORDINANCE AMENDING CHAPTER 87 ENTITLED "VEHICLES AND TRAFFIC", §87-9. SCHEDULE B: STOP INTERSECTIONS, AS AUTHORIZED BY §87-4 AND ARTICLE II. TURNING REGULATIONS, NO LEFT TURNS PER §87-14

WHEREAS, this amendment is in the best interest of health, safety and welfare of the citizens of the City of Gloucester City ("City"); and

WHEREAS, the City desires to amend Chapter 87, §87-9 by amending "A" therein; and

WHEREAS, New Jersey Statutes N.J.S.A. 39:4-140 provides the City the authority to establish the installation of stop signs at certain locations; and

WHEREAS, the Mayor and Common Council of the City of Gloucester City desire to amend to the Code of the City of Gloucester City, specifically, Chapter 87, entitled Vehicles and Traffic, specifically by creating and adding §87-9 A; and

**NOW, THEREFORE**, be it Ordained by the Mayor and Common Council of the City of Gloucester City, County of Camden and State of New Jersey as follows:

<u>Section 1</u>: The following hereby amends Part II, Chapter 87, Vehicles and Traffic, Schedule B: Stop Intersections, specifically §87-9A as follows:

- (37) Cold Springs Drive (all will be facing traffic traveling south), stop sign at the northwest corner of the northern most exit of the parking lot (approximately 100 south of Market Street);
- (38) Cold Springs Drive (all will be facing traffic traveling south), stop sign at the northwest corner of the northern most entrance to the parking lot of Cold Springs School (horseshoe driveway, which is approximately 250 feet south of Market Street);
- (39) Cold Springs Drive (all will be facing traffic traveling south), stop sign at the northwest corner of the exit of the horseshoe driveway in front of Cold Springs School (approximately 350 feet south of Market Street);
- (40) Meadowbrook Lane east bound at the main entrance gate, stop sign at River Pointe development;
- (41) Meadowbrook Lane west bound at the main entrance gate, stop sign at River Pointe development;
- (42) Southeast corner of Springdale Court at Springdale Drive, stop sign to replace a yield sign that exists at that location;

- (43) Stop sign at Northeast corner of Springdale Drive at Green Acres Lane;
- (44) Stop sign at the Northwest corner of Springdale Drive at Green Acres Lane

<u>Section 2</u>: The following hereby creates Part II, Chapter 87, Vehicles and Traffic, Schedule B: Chapter 87. Vehicles and Traffic, Article II. Turning Regulations as follows:

§ 87-14. No Left Turns.

(1) No left turn on Meadowbrook Lane facing the side exit of the Bottle Stop Liquor Store property, 56 Crescent Boulevard from the property exit onto Meadowbrook Lane.

<u>Section 3</u>: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 4</u>: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

<u>Section 5</u>: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
