

# **ORDINANCE OF THE CITY OF GLOUCESTER CITY**

**County of Camden, State of New Jersey**

**#032-2017**

## **An Ordinance Authorizing the Sale of Property**

Whereas, Gloucester City owns property located at Hudson Street, Block 37, lot 9; and

Whereas, Gloucester City is not currently using the property; and

Whereas, Gloucester City has authorized the property to be sold at Auction; and


Whereas, at Auction Gloucester City received an offer to purchase the property in the amount of \$2,750.00;

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey:

1. The Mayor and the Clerk are authorized to enter into an agreement of sale to sell Hudson Avenue to Rita Marie Chew Simmons for \$2,750.00 under the following conditions, and if all conditions are met, to execute the appropriate deed and other conveyance documents:
  - a. The property is being sold in "as is" conditions and Gloucester City makes no warranties' other than it has the right to sell the property;
  - b. Rita Marie Chew Simmons shall indemnify Gloucester City for any and all claims asserted after the sale;
  - c. Rita Marie Chew Simmons WEBO Properties, LLC acknowledges and understands that it has twelve (12) months from the date of closing to complete the renovations on the subject property and/or construct a new building on the subject property and to have a Certificate of Occupancy issued on the subject property within twelve (12) months from the date of closing. Failure to secure completion of the work and the issuance of a Certificate of Occupancy within the twelve (12) month period shall result in the property reverting to the


Seller. In addition, WEBO Properties, LLC acknowledges and understands that the properties in question shall be rehabilitated or developed to be owner occupied single family dwellings. WEBO Properties, LLC acknowledges and understands that the obligation to maintain the property as an owner occupied single family dwelling shall continue for thirty-six (36) months after the issuance of the Certificate of Occupancy. The reversion language shall be contained in the Deed transferring the property.

- d. The Solicitor for the City of Gloucester City shall prepare the deed and other conveyance documents, the cost of which \$750.00, shall be borne by Rita Marie Chew Simmons;
- e. Settlement shall take place within thirty (30) days of the adoption of this ordinance;
- f. Rita Marie Chew Simmons shall provide Gloucester City with a title report, containing the recital of how Gloucester City acquired title and the legal description of the property;
- g. Gloucester City shall bear no expenses or costs for this transaction.


