**AN ORDINANCE AMENDING CHAPTER 37 (Construction Codes, Uniform)**

**WHEREAS**, amendments need to be made to the Chapter 37 of the Code of Gloucester City; and

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Common Council of the City of Gloucester City that the following sections of the Code of Gloucester City shall be hereby amended as follows:

**§37-4. Construction Codes, Uniform.**

**Fees.**       **B)** Change \$55 to \$65 (The Minimum fee for a basic construction permit covering any or all of building, electrical, plumbing or fire protection work shall be \$65.)

**§37-4 Construction Codes, Uniform.**

Insert Mechanical subcode fees for G., then H. will be Certificate of occupancy and I. will be Variations.

**H. Certificate of occupancy**


**I. Variations**

**BE IT FURTHER ORDAINED** that all prior ordinances inconsistent with this ordinance are repealed only to the extent of such inconsistency.



**BE IT FURTHER ORDAINED** this Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.
