AN ORDINANCE CREATING THE POSITION OF PURCHASING AGENT

WHEREAS, the Mayor and Common Counsel of the City of Gloucester City ("City"), County of Camden and State of New Jersey has determined that it is in the best financial interest of its citizens to establish and create the position of Purchasing Agent; and

WHEREAS, N.J.S.A. 40A:11-9a. provides, in pertinent part, that the City may, by Ordinance in the case of a municipality, designate an individual to serve as the City's Purchasing Agent and the individual designated as the Purchasing Agent; and

WHEREAS, pursuant to law, the Purchasing Agent shall be assigned the authority, responsibility, and accountability for the purchasing activity for the contracting unit, to prepare public advertisements for bids and to receive bids for the provision or performance of goods or services on behalf of the contracting unit and approve, subject to formal action by the Mayor and Common Council, award contracts permitted by law in the name of the City and conduct any activities as may be necessary or appropriate to the purchasing function of the contracting unit as its contracting agent; and

WHEREAS, the individual designated to serve as the Purchasing Agent of the City shall possess a qualified Purchasing Agent Certificate; and

WHEREAS, the individual designated as the Purchasing Agent may be a part-time or full-time employee of the contracting unit, an independent contractor, or an individual employed by another contracting unit through a Shared Services Agreement in accordance with State law.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Common Council of the City of Gloucester City, in the County of Camden and State of New Jersey as follows:

SECTION1: Part I, Chapter 4, entitled "Administrative Code", Article V, §4-29.2, entitled Qualified Purchasing Agent is hereby created to read as follows:

§4-29-2. Qualified Purchasing Agent.

- A. There is hereby created the position of Purchasing Agent for the City of Gloucester City.
- B. The Purchasing Agent shall be appointed by the Mayor and Common Council.
- C. The Purchasing Agent is required to possess a valid Qualified Purchasing Agent Certificate, as issued by the New Jersey Division of Local Government Services, Department of Community Affairs.

- D. The Purchasing Agent shall have, on behalf of the Mayor and Common Council of the City of Gloucester City, the authority, responsibility and accountability for the purchasing activity pursuant to Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.); to prepare and/or review public advertising for and to receive bids and requests for proposals for the provision or performance of goods, services and construction contracts; to award contracts pursuant to New Jersey law in accordance with the regulations, forms and procedures promulgated by state regulatory agencies and conduct any activities as may be necessary or appropriate to the purchasing function of the City of Gloucester City.
- E. The Purchasing Agent shall operate within the bid limitation guidelines as established by the State of New Jersey as amended from tine to time.

SECTION 2: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

<u>SECTION 3</u>: If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION 4: This Ordinance shall take effect immediately upon final passage and publication as required by law.
