ORDINANCE OF THE CITY OF GLOUCESTER CITY County of Camden, State of New Jersey #007 - 2018

ORDINANCE AMENDING ARTICLE X, POLICE DEPARTMENT, §4-76 F., ENTITLED EMPLOYMENT OF OFF-DUTY POLICE DEPARTMENT MEMBERS

WHEREAS, the Mayor and Common Council of the City of Gloucester City desire to amend to the Code of the City of Gloucester City, specifically Article X, Police Department §4-76 F.; and

WHEREAS, this amendment is in the best interest of health, safety and welfare of the citizens of the City of Gloucester City ("City");

NOW, THEREFORE, be it Ordained by the Mayor and Common Council of the City of Gloucester City, County of Camden and State of New Jersey as follows:

Section 1: Current §4-76 D., is hereby amended to add paragraph 7 as follows:

7. Officers engaged in off-duty employment are required to conduct themselves in accordance with the rules of conduct of this Department and all applicable written directives. Officers are subject to suspension or revocation from extra duty privileges for violation of written directives.

Section 2: Current §4-76 F., is hereby amended to read as follows:

§4-76 F. Rates of compensation; administrative fee; payment for services.

Compensation for contracting the services of off-duty law enforcement officers are established as follows:

- 1. Rate of compensation per hour for traffic \$85.
- 2. Rate of compensation per hour for all other \$50.
- 3. Rate of compensation per hour for schools \$50. 3/hr. min. \$150.
- 4. Rate of compensation per hour for police vehicle use-\$17.50
- 5. An additional fee of \$5.00 per hour is hereby established to cover administrative costs incurred by the Gloucester City Police Department.
- 6. Schools may request waiver of the police vehicle use and administration fees.
- 7. Public utilities may post a bond in place of an escrow in the amount of \$5,000.00, which may be declared in default, if such utility fails to provide payment within one (1) week for the services rendered.

<u>Section 3</u>: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 4</u>: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment

shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

<u>Section 5</u>: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
