## ORDINANCE AUTHORIZING ROADWAY AND PARKING CHANGES

Whereas, The City wished to regulate traffic on Johnson Blvd, Park Avenue, Klemm Avenue and Morris Street; and

Whereas, The health and safety of the residents of the City of Gloucester City needs to be protected; and

Whereas, Placing stop signs on Johnson Blvd., Park Avenue, Klemm Avenue and Morris Street will help safely regulate traffic and will promote the health and safety of the residents of the City of Gloucester City; and

Whereas, The City desires to make the changes to erect stop signs on Johnson Blvd., Park Avenue, Klemm Avenue and Morris Street.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey:

The Code of the City of Gloucester shall be amended as follows:

Section 87-9 Schedule R: Stop Intersections:

Stop signs shall be placed:

- 1. On Johnson Blvd. on the northbound and southbound sides at the intersections of Paul Street, Monmouth Street.
- On Park Avenue on the northbound and southbound sides at the intersection of Gaskill Street
- 3. On Klemm Avenue on the eastbound and westbound sides at the intersection of Rosalind Street
- 4. On Johnson Blvd. on northbound/southbound sides at the intersection of Morris Street.
