ORDINANCE AMENDING CHAPTER 87 ENTITLED "VEHICLES AND TRAFFIC" TO RESTRICT PARKING WITHIN TWENTY-FIVE (25) FEET OF CERTAIN CROSSWALKS, SIDE LINE OF A STREETS OR INTERSECTING STREETS OR HIGHWAYS, AS AUTHORIZED BY N.J.S.A. 39:4-138.6

WHEREAS, this amendment is in the best interest of health, safety and welfare of the citizens of the City of Gloucester City ("City"); and

WHEREAS, the City desires to amend Chapter 87, §87-10 by adding and creating part "B." therein; and

WHEREAS, New Jersey Statutes 39:4-138.6 provides the City the authority to set certain permissible parking distances; and

WHEREAS, the City may mandate by ordinance the permissible distance a person may park a motor vehicle from a crosswalk, side line of a street or intersecting highway, or "stop" sign; and

WHEREAS, the City may not, by State Law, permit parking within 25 feet of a crosswalk or side line of a street or intersecting highway or within 50 feet of a "stop" sign in a school zone during hours when school is in session; and

WHEREAS, the Mayor and Common Council of the City of Gloucester City desire to amend to the Code of the City of Gloucester City, specifically, Chapter 87, entitled Vehicles and Traffic, specifically by creating and adding §87-10 B; and

NOW, THEREFORE, be it Ordained by the Mayor and Common Council of the City of Gloucester City, County of Camden and State of New Jersey as follows:

Section 1: The following is hereby added to Part II, Chapter 87, Vehicles and Traffic, §87-10B:

Except as expressly permitted herein, no person may park a motor vehicle in the City of Gloucester City within twenty-five (25) feet from all crosswalks, side line of a streets or intersecting streets or highways, or "stop" signs, nor within 50 feet of a "stop" sign in a school zones during hours when school is in session.

<u>Section 2</u>: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 3</u>: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

Section 4: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
