Whereas, Gloucester City has no current use for the properties; and

Whereas, Gloucester City has notified the adjoining property owners of the availability of the properties; and

Whereas, the Gloucester City tax assessor has determined the value of the properties in "as is" condition is worth no more than the following:

- a. 22 King Street, Block 39, Lot 9 \$20,000.00;
- b. 221 Powell Street, Block 70, Lot 6 \$7,000.00;
- c. 300 Morris Street, Block 25, Lot 17.01 \$7,000.00; and

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey:

- 1. The Mayor and the Clerk are authorized to enter into an agreement to sell the following properties: 22 King Street for \$20,000.00, 221Powell Street for \$7,000.00 and 300 Morris Street for \$7,000.00 to Anthony Castellano under the following conditions, and, if all conditions are met, to execute the appropriate deed and other conveyance documents;
 - Anthony Castellano shall execute an agreement of sale prepared by the Gloucester City Solicitor, the cost of which shall be borne by Anthony Castellano;

- The properties are being sold in "as is" conditions and Gloucester City makes no warranties' other than it has the right to sell the properties;
- c. Anthony Castellano, shall indemnify Gloucester City for claims asserted after the sale;
- d. The Solicitor for the City of Gloucester shall prepare the deed and other conveyance documents, the cost of which shall be borne by Anthony Castellano;
- e. Settlement shall take place within twenty (20) days of the adoption of this Ordinance;
- f. Anthony Castellano shall provide Gloucester City with a title report, containing the recital of how Gloucester City acquired title and the legal description of the properties;
- g. Gloucester City shall bear no expenses or costs for this transaction.
- 2. The Mayor is authorized to execute the agreement of sale, deed, affidavits and any other documents necessary to complete the closing and transfer the properties.
