AN ORDINANCE AMENDING CHAPTERS 36, 46, 76, and 101

WHEREAS, amendments need to be made to the Chapters 36, 46, 76, and 101 of the Code of Gloucester City; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Common Council of the City of Gloucester City that the following sections of the Code of Gloucester City shall be hereby amended as follows:

§36-4.

Issuance and expiration of license; fee.

Change \$60 to \$75 (coin controlled license)

Change 31st day of December to March 31

Add the following paragraph: Any applicant for license who does not provide the completed application form or the application fee by April 15 for the year which the license is sought shall be assessed a late fee in the amount of \$25.00 per device.

§46-3

Fee and charges.

- A. Change \$20 to \$25 (street opening application)
- **B.** Change \$5 to \$25 (curb permit fee)

§76-5

License fee.

Change \$25 to \$35 (vendor application fee)

Change \$20 to \$50 (vendor license fee per month)

Change \$50 to \$100 (vendor license fee per year)

§76-6

Badges.

Remove "The Clerk shall collect \$10 for each badge which shall be refunded upon the return of the badge.

§101-1.1 License requirements; fees

- **B.** Change first day of March to March 31 (food license)
- **D.** Change February 15 to March 31 (food license)
- E. Change March 15 to April 15 and change \$5.00 to \$10.00 (food late fee)

BE IT FURTHER ORDAINED that all prior ordinances inconsistent with this ordinance are repealed only to the extent of such inconsistency.

BE IT FURTHER ORDAINED that if any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

BE IT FURTHER ORDAINED this Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.
