ORDINANCE AUTHORIZING THE SUBDIVISION OF PROPERTY

Whereas, Theresa A. Gillespie owns property located at 28 Baynes Avenue, know as Block 158.01, lot 10; and

Whereas, Theresa A. Gillespie wishes to donate a portion of the property to the City of Gloucester City; and

Whereas, the property has been surveyed by Charles E. Adamson of Remington & Vernick Engineers On December 11, 2015; and

Whereas, it is in the best interests of the City of Gloucester City to accept the subdivided parcel; and

Whereas, The City of Gloucester City has previously adopted an ordinance authorizing the acquisition of the property; and

Whereas, The City and Gloucester and Theresa A. Gillespie have previously entered into an agreement of sale regarding the property;

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the City of Gloucester City, County of Camden, State of New Jersey:

- 1. The property shall be deemed subdivided by this ordinance;
- 2. The remaining parcel, containing approximately 1.271 acres shall remain the property of Theresa A. Gillespie and shall continue to be known as Block 158.01, Lot 10, as described by the aforementioned survey;
- 3. The subdivided parcel, containing approximately .296 acres, shall be known as Block 158.01, Lot 10.1 (or by such other Lot designation as determined by the tax office) as described in the aforementioned survey shall be the property of the City of Gloucester City;

- 4. This transaction is conditioned upon Theresa A. Gillespie securing a release of part of mortgage premises for the parcel being acquired by the City of Gloucester City;
- 5. All deeds and other documents necessary to complete the subdivision shall be prepared by the Gloucester City Solicitor;
- 6. All title expenses, closing costs, recording fees and other expenses related to this transaction shall be borne by the City of Gloucester City;
- 7. Settlement shall take place when the minor subdivision is not appealable.
