ORDINANCE OF THE CITY OF GLOUCESTER CITY County of Camden, State of New Jersey #O- 15 -2020

AN ORDINANCE CONFIRMING AND AUTHORIZING THE SALE OF LANDS IN ACCORDANCE WITH THE REQUIREMENTS OF THE LOCAL LANDS AND BUILDINGS LAW FOR BLOCK 19, LOT 12, KNOWN AS 218 NORTH KING STREET; BLOCK 45, LOT 21, KNOWN AS 215 MONMOUTH STREET; BLOCK 41, LOT 39, KNOWN AS 337 BERGEN STREET; AND BLOCK 64, LOT 1.02, KNOWN AS 346 RIDGEWAY STREET IN THE CITY OF GLOUCESTER CITY, COUNTY OF CAMDEN AND STATE OF NEW JERSEY

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Common Council of the City of Gloucester City, as follows:

Section 1: The Mayor and Common Council of the City of Gloucester City, County of Camden, State of New Jersey, that the sale of properties located at Block 19, Lot 12 on the City of Gloucester City Tax Map, also known as 218 North King Street; Block 45, Lot 21 on the City of Gloucester City Tax Map, also known as 215 Monmouth Street, Gloucester City; Block 41, Lot 39 on the City of Gloucester City Tax Map, also known as 337 Bergen Street, Gloucester City; and Block 64, Lot 1.02 on the City of Gloucester City Tax Map, also known as 346 Ridgeway Street, Gloucester City, New Jersey, is hereby confirmed and ratified.

Section 2: The Mayor and Common Council hereby authorizes the sales of said properties subject to an express condition that the premises be owner occupied, which shall be a condition of the Deed of transfer.

<u>Section 5:</u> If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such section, paragraph, clause or provision and the remainder of the Ordinance shall be deemed valid and effective.

Section 6: This Ordinance shall take effect immediately upon final passage and publication as provided by law.
