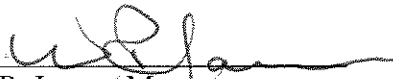

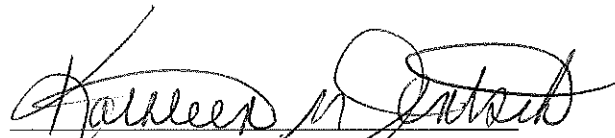
BE IT FURTHER RESOLVED by the Mayor and Common Council of Gloucester City that the following be awarded extraordinary unspecifiable services contracts:
