ANIMAL CRUELTY INVESTIGATOR**


**WHEREAS**, there exists a need for Animal Control Services for the City of Gloucester City; and

**WHEREAS**, there exists a need for an Animal Cruelty Investigator; and


**WHEREAS**, funds are available for said services as evidenced by the attached Certificate of Availability of Funds issued by the Chief Financial Officer.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of Gloucester City that, in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., NANCY WELSH, New Jersey Certified Animal Control Officer #1436, t/a MAIN COMMUNITY CARE SERVICES, 333 VIRGINIA AVE., COLLINGSWOOD, NJ 08108 is hereby awarded a contract in the amount of Ten Thousand Four Hundred and Sixty Four Dollars (\$10,464.00) for one year beginning January 1, 2019 and ending December 31, 2019 for animal control and animal cruelty investigation services; and
