This is to request an award of a contract without the receipt of formal bids as an Extraordinary Unspecifiable Service [N.J.S.A. 40A:11-5(1)(a)(ii) and N.J.A.C. 5:34-2.3(b)]. I do hereby certify to the following:

1. Provide a clear description of the nature of the work to be done.

Voorhees Animal Orphanage, Inc. will house, shelter, feed and care for all felines and canines found or otherwise acquired in Gloucester City with exception of injured or sick that have been diagnosed or are suspected of having a communicable disease, which are determined by the VAO to endanger the health of the other animals at the shelter.

2. Describe in detail why the contract meets the provisions of the statute and rules.

Quotations were not solicited as the nature of the service is specific to capabilities in the field animal shelter services. The prospective contractor has specialized characteristics and experience in the field required.

3. The service(s) is of such a specialized and qualitative nature that the performance of the service(s) cannot be reasonably described by written specifications because:

The services do not lend themselves to written specifications, as they are more qualitative in nature than quantitative. The ability to provide appropriate service is more of a determinant of the contract suitability than price. It will be in the best interest of the City to award this contract to Voorhees Animal Orphanage in amount of \$39,000.00

4. Describe the solicitation of quotes.

Quotes were not solicited from alternate firms because of the expertise exhibited by this firm communicated to us by other municipalities.

5. I have reviewed the rules of the Division of Local Government Services pursuant to N.J.A.C. 5:34-2.1 et seq. and certify that the proposed contract may be considered an extraordinary unspecifiable service in accordance with the requirements thereof.
