## RESOLUTION OF THE CITY OF GLOUCESTER CITY, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AUTHORIZING EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE BOROUGH OF BROOKLAWN FOR THE RENTAL OF CERTAIN PUBLIC WORKS EQUIPMENT

WHEREAS, the Mayor and Common Council of the City of Gloucester City ("City") and the Borough of Brooklawn ("Brooklawn") wish to enter into a Shared Services Agreement ("SSA") to share certain equipment and reduce costs through the rental of certain Public Works Equipment (Trash Truck); and

WHEREAS, the Brooklawn may, during the course of Calendar Year 2021, have the need for short term rentals of certain public works equipment, to wit, a trash removal vehicle, for use within the Borough of Brooklawn; and

WHEREAS, Gloucester City is willing to rent such a vehicle to Brooklawn under the terms and conditions as set forth below; and

WHEREAS, Brooklawn has agreed to pay Brooklawn the sum of Two Thousand Dollars (\$2,000.00) per month for the rental of the trash removal vehicle for four (4) days for every week within the respective month of the rental, commencing January 1, 2021 and terminating on December 31, 2021, to be paid in accordance with the payment schedule as follows; and

WHEREAS, Brooklawn and the City have set forth the terms and conditions of this SSA in the Agreement attached hereto and made a part hereof; and

WHEREAS, Mayor and Common Council desire to authorize the execution of the SSA pursuant to this authorizing Resolutions; and

WHEREAS, by entering into the SSA, the City and Brooklawn agree that the shared use of the aforementioned services benefits each public entity equally; and

WHEREAS, all contractual provisions have been negotiated in the aforementioned SSA; and

**WHEREAS**, the Uniform Shared Services N.J.S.A. 40A:65-1 et seq., authorizes and empowers the City and Brooklawn to enter into this SSA; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of Gloucester City, County of Camden and State of New Jersey as follows:

- 1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
- 2. The Mayor and Common Council of the City of Gloucester hereby authorizes and approves the Shared Service Agreement in a form attached hereto and made a part hereof and authorizes the Mayor, City Clerk and/or their respective designees to take and all actions necessary to effectuate the intent of this Resolution.
- 3. Pursuant to N.J.S.A. 40A:65-4, the subject SSA shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
- 4. A copy of the SSA shall be open to public inspection at the offices of the City Clerk immediately after passage of this Resolution.
- 5. The SSA shall take effect upon the adoption of appropriate resolutions by all the parties thereto, and execution of agreements authorized thereunder as set forth in the SSA.
