**RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BY AND BETWEEN  
THE CAMDEN COUNTY IMPROVEMENT AUTHORITY, BOROUGH OF BROOKLAWN,  
BOROUGH OF BARRINGTON, BOROUGH OF BELLMAWR, BOROUGH OF WESTVILLE  
AND THE CITY OF GLOUCESTER**

**WHEREAS**, the Camden County Improvement Authority (“CCIA”) performs program management services (“Services”), project and construction management services, for programs and individual Projects involving the County of Camden, its affiliated agencies and municipalities to maximize economies and efficiencies in the operations of County or Municipal/City governments; and

**WHEREAS**, the Camden County Municipal Utilities Authority (“CCMUA”) has the technical knowledge of regional storm and waste water systems and has assisted Municipalities/Cities with studies in the past; and

**WHEREAS**, the CCIA shall receive up to five hundred thousand dollars of State of New Jersey funds for a Regional Stormwater Management Study within the Municipalities (“Project”); and

**WHEREAS**, the City of Gloucester City desires to enter into a Shared Services Agreement (“SSA”) as attached; and


**WHEREAS**, CCIA and CCMUA have the expertise and capability to provide comprehensive Project Management Services to the Municipalities for the authorization and management of this Project;

**WHEREAS**, N.J.S.A. 40A:65-1, et seq. (“Uniform Shared Services and Consolidation Act”) permits local units to enter into a contract for any service which any party to the agreement is empowered to render within its jurisdiction; and

**WHEREAS**, the CCIA, CCMUA, and the Municipalities/City agree that their mutual public purposes and their best interest will be promoted by the execution and delivery of this Shared Services Agreement pursuant to the powers conferred by the Uniform Shared Services and Consolidation Act; and

**NOW, THEREFORE, BE IT RESOLUTION**, by the Mayor and Common Council of the City of Gloucester, County of Camden and State of New Jersey as follows:


1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
2. The Mayor and Common Council of the City of Gloucester hereby authorizes and approves the Shared Service Agreement in a form attached hereto and made a part hereof and authorizes the Mayor, City Clerk and./or their respective designees to take and all actions necessary to effectuate the intend of this Resolution.
3. Pursuant to N.J.S.A. 40A:65-4, the subject SSA shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
4. A copy of the SSA shall be open to public inspection at the offices of the City Clerk immediately after passage of this Resolution.
5. The SSA shall take effect upon the adoption of appropriate resolutions by all the parties thereto, and execution of agreements authorized thereunder as set forth in the SSA.
