**RESOLUTION AUTHORIZING A PERSON-TO-PERSON TRANSFER OF PLENARY  
RETAIL CONSUMPTION LIQUOR LICENSE 0414-33-031**

**WHEREAS**, an application has been filed for a Person-to-Person Transfer of Plenary Retail Consumption License 0414-33-031, heretofore issued to Shamrock Road, LLC, 419 Highland Blvd. Gloucester City, NJ; and

**WHEREAS**, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current licensing term; and

**WHEREAS**, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

**WHEREAS**, the applicant has disclosed and the Common Council of Gloucester City has reviewed the source of all funds used in the purchase of the license and the licensed business and all additional financing obtained in connection with the licensed business; and

**WHEREAS**, the applicant has published a notice of application in the Gloucester City News, said notice appearing in both the December 15 and 22, 2016 editions of said newspaper, and the City Clerk has not received a written objection thereto.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of the City of Gloucester City, County of Camden, State of New Jersey that Plenary Retail Consumption License Number 0414-33-031 issued to Shamrock Road, LLC, premises situated at 419 Highland Blvd., Gloucester City, New Jersey, be transferred to Elizabeth Ballroom, LLC, trading as Dolson Family Catering, LLC and The Elizabeth Ballroom operating at the same premises.

**BE IT FURTHER RESOLVED** that this license is being used in conjunction with a catering use previously existing on the site. No public barroom or restaurant may be established at the site; no packaged goods may be sold from the site. The City Clerk is hereby authorized to endorse the license certificate as follows: "This license, subject to all of its terms and conditions, is hereby transferred to Elizabeth Ballroom, LLC and to premises located at 419 Highland Blvd., Gloucester City, New Jersey, effective December 28, 2016 – Catering Use Only: No public barroom, restaurant or packaged goods sales". Said license shall become active on this same date.

**BE IT FURTHER RESOLVED** that Kathleen M. Jentsch, City Clerk, is hereby authorized to execute the endorsement of said transfer.
