RESOLUTION ESTABLISHING A STEERING COMMITTEE FOR THE 150TH CHARTERING OF THE CITY OF GLOUCESTER CITY IN THE YEAR 2018 AND THE 400TH ANNIVERSARY OF THE ORIGINAL SETTLEMENT OF FORT NASSUA ON THE DELAWARE RIVER IN 2023, AND APPOINTING MEMBERS TO SAID COMMITTEE

Whereas, the City of Gloucester City will be celebrating the 150th anniversary of the chartering of Gloucester City in 2018, and celebrating the 400th anniversary of the original settlement of Fort Nassau on the Delaware River in 2023; and

Whereas, there is a need to begin planning, promoting, funding, and researching the various activities and celebrations to commemorate these milestone achievements; and

Whereas, by passage of this Resolution, the Mayor will appoint members to this Steering Committee with the advice and consent of City Council so that said Committee may begin their work over the next two years that is paramount to such a large endeavor; and

Whereas said Committee will have all authority and rights to plan and execute all components of this large Celebration on behalf of the Mayor and Council and the citizens of Gloucester City.


