**RESOLUTION TO ACCEPT CAMDEN COUNTY DEPARTMENT OF HOMELAND  
SECURITY, EMERGENCY MANAGEMENT AGENCY ASSISTANCE PERFORMANCE  
GRANT PROGRAM FUNDING FOR THE FEDERAL FISCAL YEAR 2015**

**WHEREAS**, the City of Gloucester City, Office of Emergency Management has been awarded the Emergency Management Agency Assistance Grant Program CFDA #97.042, from the New Jersey State Police Office of Emergency Management. The sub-grant, consisting of an amount not to exceed \$7,000.00 federal award and \$7,000.00 local matching funds, is for the purpose of enhancing Gloucester City's ability to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies; and

**WHEREAS**, the Sub-grant award incorporates all conditions and representations contained or made in application; and


**WHEREAS**, the City of Gloucester City, Office of Emergency Management, designated by the New Jersey State Police, Office of Emergency Management, has submitted an application for Sub-grant award that has been required by the New Jersey State Police, Office of Emergency Management for the period of July 1, 2015 to June 30, 2016; and

**WHEREAS**, the application for Sub-grant award calls for a match in an amount not to exceed \$7,000.00. The Chief Financial Officer has certified funds in the amount of \$7,000.00 through the FY16 Police Budget.


**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Common Council of Gloucester City herewith accepts the award of the Federal FY15 Homeland Security Emergency Management Performance Grant Program FY15-EMPG-EMAA-0414, Sub-grant in the amount not to exceed \$7,000 federal funds from the New Jersey State Police, Office of Emergency Management; and

**BE IT FURTHER RESOLVED** by the Mayor and Common Council of Gloucester City, County of Camden, State of New Jersey, that the Mayor or his designee is authorized to execute such documents consistent with this Resolution and to take such other action on behalf of the City in furtherance of this Resolution.
