**RESOLUTION REQUESTING PERMISSION OF THE DIRECTOR OF LOCAL
GOVERNMENT SERVICES TO ANTICIPATE SPECIAL ITEM OF REVENUE
IN THE 2019 BUDGET OF THE CITY OF GLOUCESTER CITY PURSUANT TO
N.J.S.A. 40A:4-87
(CHAPTER 159, P.L. 1948)**

WHEREAS, N.J.S.A. 40A:4-87 authorizes a municipality to anticipate a special item of revenue and appropriate such revenue with the consent of the Director of Local Government Services when such item shall have been made available by law and the amount thereof shall not have been determined at the time of the adoption of the budget, and

WHEREAS, the City of Gloucester City has been awarded a \$173,635.31 Safe Routes to School Program Grant from the New Jersey Department of Transportation, and

WHEREAS, the Mayor and Common Council of the City of Gloucester City desire to anticipate and appropriate the revenue in the 2019 Annual Budget for the benefit of the citizens of Gloucester City;

SECTION 1

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of Gloucester City, County of Camden, that the Director of the Division of Local Government Services be and is hereby requested to approve the insertion of an item of revenue in the budget of the year 2019 in the sum of \$173,635.31 which item is now available as a revenue from a Safe Routes to School Grant, and


SECTION 2


SECTION 3
