**RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BY AND BETWEEN  
THE BOROUGH OF BELLMAWR AND THE CITY OF GLOUCESTER CITY, COUNTY OF  
CAMDEN, STATE OF NEW JERSEY, REQUIRING THE RENTAL OF EQUIPMENT AND  
MANPOWER NECESSARY FOR ASPHALT REHABILITATION AND CONCRETE  
REHABILITATION OF VARIOUS ROADWAYS AND PUBLIC GROUNDS WITHIN THE  
CITY OF GLOUCESTER CITY**

**WHEREAS**, the City of Gloucester City ("City") and the Borough of Bellmawr ("Borough") desire to enter into a Shared Services Agreement pursuant to the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1 et seq.) ("Shared Services Act"), N.J.S.A. 40A:65-1 et seq., in order to effectuate efficiency of services within both Communities; and

**WHEREAS**, the City is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, the Borough is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, City and Borough wish to enter into an Agreement whereby the Borough would provide Manpower and Equipment for the purpose of asphalt/concrete/sewer rehabilitation of various roadways and public grounds within Gloucester City; and

**WHEREAS**, as a result of fair negotiations between the Borough and the City, the terms and provisions of a Shared Services Agreement have been completed in a form attached hereto and made a part hereof; and

**WHEREAS**, the proper and respective public officials are or will be authorized to execute this Shared Services Agreement pursuant to Resolutions of their respective governing bodies; and

**WHEREAS**, under the Shared Services Act, any local unit may enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction, including services incidental to the primary purposes of any of the participating local units; and

**WHEREAS**, by Resolution adopted on August 25, 2022, the Borough intends to authorized the execution of the Shared Services Agreement with the City for the aforesaid services; and


**WHEREAS**, by Resolution adopted August 18, 2022, the City authorized the execution of the Agreement with the Borough for the services aforesaid; and

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Common Council of the City of Gloucester City in the County of Camden and State of New Jersey as follows:

1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
2. The Mayor and/or Common Council are authorized to take any and all actions necessary to execute a Shared Services Agreement by and between the City of Gloucester and the Borough of Bellmawr and perform all other functions to effectuate the purposes thereof.
3. The Agreement shall be attached to this Resolution upon execution and kept on file in the Office of the City Clerk of the City of Gloucester City.
4. The subject Shared Services Agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
5. This Resolution shall take effect immediately.
