## RESOLUTION OF THE CITY OF GLOUCESTER CITY County of Camden, State of New Jersey #R 202 - 2021

RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BY AND BETWEEN THE CITY OF GLOUCESTER CITY AND THE CAMDEN COUNTY IMPROVEMENT AUTHORITY FOR THE PROVISION OF PROFESSIONAL REDEVELOPMENT SERVICES

WHEREAS, the City of Gloucester City ("City") and the Camden County Improvement Authority ("CCIA") are both Local Units and are permitted, in accordance with N.J.S.A. 40A:65-1 et seq., the Uniform Shared Services and Consolidation Act ("Act"), to enter into an Agreement to provide jointly, or through each respective agency itself, such services authorized by the Act, including areas of general government administration, such as shared services; and

WHEREAS, the CCIA performs Redevelopment Services ("Services"), for programs and individual Projects involving the County of Camden, its affiliated agencies and municipalities to maximize economies and efficiencies in the operations of County or Municipal government; and

WHEREAS, City is presently in need of procuring an entity to provide Redevelopment Services for certain portions of the City including, but not limited to, areas along Broadway, Market Street and King Street ("Project"); and

WHEREAS, CCIA has the expertise and capability to provide comprehensive Services to the City for the management of this Project; and

WHEREAS, N.J.SA. 40A:65-1, et seq ("Uniform Shared Services and Consolidation Act") permits two local units to enter into a contract for any service which any party to the agreement is empowered to render within its jurisdiction; and

WHEREAS, the CCIA and the City agree that their mutual public purposes and their best interest will be promoted by the execution and delivery of this Shared Services Agreement pursuant to the powers conferred by the Uniform Shared Services and Consolidation Act; and

WHEREAS, by Resolution No  $\underline{\beta b 2}$  adopted by the City's Mayor and Common Council, and Resolution No. \_\_\_\_ adopted by the Camden County Improvement Authority, the Parties are authorized to enter into this Agreement;

WHEREAS, this Agreement is established in accordance with the provisions of the "Uniform Shared Services and Consolidation Act", P.L.2007, c.63 (C.40A:65-l, et seq.), approved on April 3, 2007 as a means for local units to engage in more efficient operations and services in a cost-effective manner.

**THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of the City of Gloucester City, County of Camden and State of New Jersey as follows:

- 1. The provisions of the **WHEREAS** clauses set forth above are incorporated herein by reference and made a part hereof.
- 2. The Mayor and Common Council of the City of Gloucester City hereby authorizes and approves the Shared Service Agreement in a form attached hereto and made a part hereof and authorizes the Mayor, City Clerk and/or their respective designees to take and all actions necessary to effectuate the intend of this Resolution.
- 3. Pursuant to N.J.S.A. 40A:65-4, the subject SSA shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
- 4. A copy of the SSA is open for public inspection at the offices of the City Clerk and shall remain so upon adoption of this Resolution.
- 5. The SSA shall take effect upon the adoption of appropriate resolutions by all the parties hereto, and execution of agreements authorized thereunder as set forth in the SSA.
