ORDINANCE AMENDING FEES FOR THE CITY MARINA FOR CERTAIN USES AND RENTALS ESTABLISHED BY THE CITY OF GLOUCESTER CITY, COUNTY OF CAMDEN AND STATE OF NEW JERSEY

WHEREAS, the Mayor and Common Council of the City of Gloucester City desire to establish certain fees for the City Marina usage and rentals; and

WHEREAS, codification of said fees with ensure uniformity and equity between various recreational uses at the City's Marina property.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Mayor and Common Council of the City of Gloucester City, County of Camden, State of New Jersey, as follows:

SECTION 1: The Mayor and Common Council hereby amend the Code of the City of Gloucester City to establish fees for the usage and rental of various uses at the City Marina as follows:

The following fees are establishing for the City Marina:


<u>Usage Type</u>	<u>Fees</u>
Daily Boat Launch	\$20.00 per launch
Seasonal Boat Launch	\$175.00 for the season
Daily Jet Ski Launch	\$10.00 per launch
Seasonal Jet Ski Launch	\$100.00 for the season
Overnight Dockage	\$25.00 per night
Transient dock uses up to 4 hrs.0	\$10.00 for up to 4 hrs.
Sewage Pump Out	\$10.00 per event
Key Deposit	\$25.00 (\$20.00 refundable)
Seasonal Dockage	\$850.00 through November 30
A/B Seasonal Dockage	\$850.00 plus key
C Seasonal Dockage	\$850.00 plus \$100.00 for water/electric
Monthly Dockage	\$275.00 per month
Monthly A/B Dockage	\$275.00 a month plus key
Monthly C Dockage	\$275.00 plus \$40.00 for water/electric

SECTION 2: This Ordinance shall remain in effect from adoption through the end of the Marina Season, November 30, 2020.

SECTION 3: All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.


SECTION 4: The provisions of this Ordinance shall supersede the terms of any previous site plan approval, to the extent there is any conflict therewith.

SECTION 4: This Ordinance shall take effect as set forth above and upon final passage and publication in accordance with law.




PUBLIC MEETING
