No person shall park or leave unattended any moving container, moving pod, storage pod or other similar containers commonly used to facilitate moving personal property, on or along any public highway or right-of-way or on public property, without first obtaining permits from the Housing and Building Department in the amount of \$25.00. Consent shall be valid and remain in effect for a period of not more than 15 calendar days but may be renewed by the Construction Official after appropriate application and approval.

Applicant will notify the Police Department upon approval of application as to the location of the container.

Failure to submit required application and fee or failure to remove the approved container by expiration date may result in a fine of not less than \$100.00 and not more than \$2,000.00 and/or a period of community service not exceeding 90 days.

ORDINANCE OF THE CITY OF GLOUCESTER CITY

County of Camden, State of New Jersey

#008-2006

AN ORDINANCE AMENDING SECTION 87-62 OF THE CODE OF GLOUCESTER CITY ENTITLED 'ROLL-OFF DUMPSTERS AND CONTAINERS'

WHEREAS, the Governing Body of Gloucester City have found the need to amend §87-62 to include the occurrence of storage pods within the city.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Common Council of the City of Gloucester City that Chapter 87, Article III, Section 62 of the Code of Gloucester City is hereby amended by including the following additional section thus:

SECTION 1.

§87-62.1. Storage pods and moving containers.

- A. No person shall park or leave unattended any moving container, moving pod, storage pod or other similar containers commonly used to facilitate moving personal property, on or along any public highway or right-of-way or on public property, without first obtaining permits from the Housing and Building Department. The Permit shall be in the amount of \$25.00 and will remain in affect for a period of not more than 15 calendar days; however, may be renewed by the Construction Official after appropriate application and approval. Applicant will notify the Police Department upon approval of application as to the location of the container.
- B. Failure to submit the required application and fee or failure to remove the approved container by the expiration date may result in a fine of not less than \$100.00 and not more than \$2,000.00 and/or a period of community service not exceeding 90 days.

SECTION 2.

BE IT FURTHER ORDAINED that all prior ordinances inconsistent with this ordinance are repealed only to the extent of such inconsistency.


BE IT FURTHER ORDAINED that if any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

BE IT FURTHER ORDAINED this Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.


